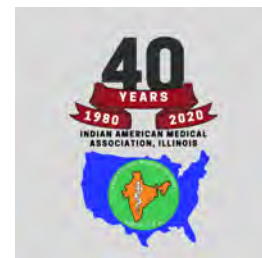

Financial Narrative 2020

This narrative provides an understanding of changes in the Indian American Medical Association's cash position across funds and investment types. The organization's cash balance has decreased \$10,412.55 between fiscal years at the end of December 2020.

IAMA-IL operates via Cash-Based Accounting therefore the following statements accurately reflect the bank account transactions as of December 31, 2020, but do not encompass all activities related directly to 2020. Please review this narrative for more details.

Each fund varies for its own reasons. In general, cash balances increase in the fourth quarter of the fiscal year as a majority of event revenue is received in November. Even though cash balances are \$267,993.50, they are \$113,891.13 less than a five years ago.

This is consistent with the information provided last year including our operational costs have remained steady, we did not raise membership dues or increase our membership numbers and capital projects have reduced reserves.

Event Related Expenses are at 60.67% of the annual budget for the year with Administrative Related Expenses at 30.11% and Charity Program and Donation Expenses under the 10% mark.

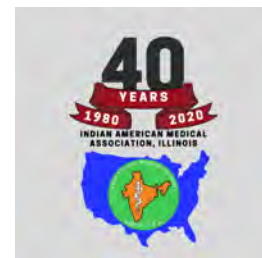
The Statement of Activity - Revenues by Account provides an overview of total resources by account for the year. More telling information is found later in this report in the individual account statements narratives to help the reader get a "sense" of how the year is progressed.

An overview by account is as follows:

Non-Profit Revenue – Revenue received by the organization not earmarked for other use, such as donations for National Giving Tuesday, and donations for COVID/PPE.

Membership – Revenue received as a result of new member dues.

Sponsorship – Revenue received as a sponsorship in exchange of an advertisement being placed in our monthly newsletters.



Events –

Gala – Revenue related to the Annual Gala. The 2020 report reflects payments received for the 2019 event in the fiscal year 2020, these are reflected in the following accounts:

- Gala Banquet – Ads
- Donations at Gala
- Gala Banquet – Tickets – revenue from 2018 & 2019 ticket sales

Income received as a sponsorship of the 2020 Gala is reflected in the Gala Banquet – Sponsorship line.

Golden Stethoscope Awards – Revenue related to the Golden Stethoscope Awards event; all revenue is related to 2020 activities. However, these numbers do not represent the sponsorship amount pledged in 2020 and received in early 2021 from the **Indima Foundation totaling \$5,000.00.**

Event Rev. – Revenue received from other events throughout 2020.

The Statement of Activity - Expenses is intended to present expenditures on a budget basis by account

An overview by account is as follows:

Administrative Expenses – Expenses related to the administrative duties of IAMA-IL can be observed in the Operating Expenses Accounts. Accounts of notice include the expenses related to Office Furniture/Equipment which is related to the purchase of a new PC for office and event related activities, this purchase was made possible by the generous donations of the 2020 Executive Committee Members, which can be observed in the Other Income Revenue Account towards the end of this statement.

Bank Charges – The expenses reflected as PayPal Fees relate to the percentage charged by PayPal to process credit card payments and donations made via credit card. These fees are standard and are based on our non-profit status, there is currently not a system in place with less fees.

Event Expenditures – Expenses related to events. The 2020 report reflects some expenses for events held in 2019 and payments processed in the fiscal year 2020, these are reflected in the following accounts, other expenses are for events occurring in 2020.

- Gala Banquet – Photography, Video & Sound - 2019
- Travel Expenses for India CPR Program – 2019



Interest – Revenue paid as interest earned from accounts at BMO Harris Bank and US Bank.

Other Income – Generous donations from Executive Committee and Board of Director Members towards the purchase of a new computer for office/event use.

Reconciliation Discrepancies – This discrepancy is related to the PayPal account and is being investigated by the Administrative Secretary and the 2020 Treasurer. This discrepancy occurred in early 2020.

IAMA-IL– Revenue and Expenditures are consistent with budgeted activities for the year.

There were two pledges made in 2020 which were fulfilled in early 2021. Accounting for these in the 2020 year in review would adjust the total loss for the year to be \$5,312.55.
